Please Remember:

Possible Elective Topics (Elective topics must be taught for at least 8 hours):

- Hazard Communications/Hazardous Materials
- Lockout/Tagout
- Respiratory Protection
- Fall Protection
- Electrical
- Confined and Enclosed Spaces
- Fire Protection

Possible Optional Topics (Optional topics must be taught for at least 14 hours):

- Hot Work – Welding, Burning & Cutting
- Material Handling
- Bloodborne Pathogens (Exposure Plan, Universal Precautions, Spills & Decontamination)
- Machine Guarding
- Ergonomics and Proper Lifting Techniques (repetitive motion & muscle strains)
- Additional Coverage on mandatory or elective topics or on any other Maritime Industry standards or policies
